**1. Mr. Puneet Singh Bindra, learned counsel

2. Mr. Devender Singh, Assistant General Manager (Legal), Bank of Baroda, is present, duly represented by the counsel appearing for the respondent-Bank, Ms. Praveena Gautam.

3. The parties have agreed that the respondent-Bank shall pay Compassionate Allowance to the petitioner in terms of Regulation 31 of the Banking Pension Regulations. In pursuance thereof, the petitioner shall be entitled to a monthly allowance of Rs.44,040/- (Rupees Forty-Four Thousand and Forty Only) with effect from 01.09.2026. The first monthly allowance shall be disbursed on or before 30.09.2026.

4. It is further clarified that, in accordance with the Banking Pension Regulations, in the event of the death of the petitioner, the family pension shall be admissible to the dependents.

5. The petitioner, having consented to the aforesaid arrangement, this petition stands

disposed of in terms of the settlement. Award be drawn accordingly.
