Pursuant to Regulation 30 of SEBI Listing Regulations read with SEBI Master Circular bearing reference number HO/49/14/14(7)2025-CFD-POD2/I/3762/2026 dated January 30, 2026, we wish to inform you that CareEdge ESG Ratings has assigned Adani Ports and Special Economic Zone Limited ("APSEZ") an ESG score of 84.3 (ESG rating: CareEdge-ESG 1+, representing "Leadership" position in managing ESG risks through best-in-class disclosures, policies and performances), an improvement of 3.3 points over its previous score of 81.
