Sub: General updates - Withdrawal of application made for Reclassification of Existing Promoter and Promoter Group as Public Shareholders pursuant to Regulation 31A(9) of the SEBI (LODR) Regulations, 2015.

Reference: Bloom Dekor Limited (Security Id: BLOOM Security Code: 526225)

With reference to our outcome of Board meeting dated August 07, 2026 in the matter of reclassification of the entire existing Promoter and Promoter Group of the Company from "Promoter/Promoter Group" to "Public" pursuant to Regulation 31A of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI LODR Regulations"), we wish to place the following facts and submissions before the Stock Exchange for its kind consideration.

The proposed reclassification of the existing Promoter and Promoter Group has arisen pursuant to the **Resolution Plan approved by the Hon'ble National Company Law Tribunal, Ahmedabad Bench ("Hon'ble NCLT") vide its order dated June 18, 2026 under Section 31 of the Insolvency and Bankruptcy Code, 2016 ("IBC").**

Pursuant to the approval of the Resolution Plan, the Company had duly intimated the Stock Exchange on **June 19, 2026**, under Regulation 30 of the SEBI LODR Regulations, regarding the approval of the Resolution Plan by the Hon'ble NCLT, Ahmedabad Bench. The said disclosure was made within twenty-four hours of the approval of the Resolution Plan and contained the requisite details regarding the approval and implementation of the Resolution Plan and the consequential changes contemplated thereunder.

In this connection, we draw attention to **Regulation 31A(9) of the SEBI LODR Regulations**, which specifically provides an exemption in cases where reclassification of promoter(s) is pursuant to a resolution plan approved under Section 31 of the IBC or pursuant to an order of a Regulator under any law.

The Resolution Plan approved by the Hon'ble NCLT is squarely covered within the specific circumstances contemplated under Regulation 31A(9), being a resolution plan approved under **Section 31 of the IBC**.

Further, pursuant to the approval and implementation of the Resolution Plan, the erstwhile Promoter and Promoter Group do not continue to exercise control over the Company. Accordingly, the reclassification contemplated under the approved Resolution Plan is in the nature of a reclassification specifically covered by Regulation 31A(9).

Based on the aforesaid facts and the specific exemption provided under Regulation 31A(9), the Company understands that the requirements prescribed under Regulations 31A(3), 31A(4) and 31A(8) are not applicable to the present case, as the reclassification is being effected pursuant to a Resolution Plan approved under Section 31 of the IBC.

In view of the above, we respectfully submit that the proposed reclassification of the entire existing Promoter and Promoter Group as Public Shareholders is pursuant to the Resolution Plan approved by the Hon'ble NCLT under Section 31 of the IBC and is accordingly covered under the specific provisions of Regulation 31A(9) of the SEBI LODR Regulations and there is no specific requirement for application of reclassification.

Accordingly, the Company hereby take on record the withdrawal of Application made for reclassification of the existing Promoter and Promoter Group as Public Shareholders.



We further request the Stock Exchange to kindly take note of the disclosure already made by the Company on **June 19, 2026** pursuant to Regulation 30 of the SEBI LODR Regulations and consider the same in the context of the requirements prescribed under Regulation 31A(9)(b) of the SEBI LODR Regulations.
