ORDER

3. Mr. Vishesh Kalra, Advocate, appears for Respondent No. 2.
4. Learned counsel for Respondent No. 2 submits that, consequent upon the substitution of the Resolution Professional (RP) by the SRA, he seeks permission to file an additional affidavit in addition to the reply already filed and prays for two weeks' time for the same, which is opposed by Ld. Counsel of SRA.
5. Let the additional affidavit be filed within two weeks, with an advance copy to the opposite party.
6. Learned counsel for Respondent Nos. 1 and 3 also seeks time to file a reply, which is opposed by learned counsel for the SRA.
