Further to our letter dated August 03, 2026, on the subject cited above, we wish to inform you that the said disclosure is being revised to explicitly include the specific quantum of differential customs duty proposed in the Demand cum Show Cause Notice, which was omitted in the Annexure-A enclosed with our initial letter. The revised Annexure-A, incorporating the details for better clarity of the stakeholders and the Exchange, is enclosed herewith.

Pursuant to Regulation 30 read with Schedule III of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform you that the Company has received a Demand cum Show Cause Notice No. 29/PC/2026-27 dated July 29, 2026 (File No. GEN/ADT/PCA/111/2026-ICD-BBG-CUS-COMMRTE-PPG-DELHI), issued by the Office of the Principal Commissioner of Customs, ICD PPG & Other ICDs, Delhi. The said show cause notice has been received by the Company on July 30, 2026.

The details of the notice as required under the Listing Regulations read with SEBI Master Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024, are attached as Annexure-A (Revised).

Details of fines, penalties, violation(s)/contravention, dues, etc. including amount	The Company has received a Demand cum Show Cause Notice under Section 28(4) read with Section 99A of the Customs Act, 1962, The notice pertains to the classification of certain goods imported by the Company during FY 2022-23 and FY 2023-24 and has proposed a differential customs duty demand of approximately Rs. 6.72 crore (6,72,42,832), excluding applicable interest and penalty, arising from a difference in the interpretation of customs tariff classification.
5.	Nature and details of the action(s) taken or order passed	The notice is presently at a preliminary stage, and no final determination has been made by the adjudicating authority. The Company believes that the imports were undertaken based on its bona fide understanding of the applicable customs classification and is in the process of obtaining appropriate legal and technical advice. A detailed response will be submitted within 30 days from the date of receipt, and the Company will pursue all remedies available under applicable law.
6.	Impact on financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible	Based on its preliminary assessment, the management does not expect any immediate impact on the Company's operations arising from receipt of the notice. The financial implications, if any, will be determined upon completion of the adjudication process and in accordance with applicable legal and accounting requirements.

Note: The aforesaid Show Cause Notice has been received by the Company and is presently under examination. The Company is in the process of formulating its response and shall submit the same before the competent authority within the stipulated period. The matter shall be pursued diligently in accordance with applicable legal provisions, and the Company is taking all necessary measures to protect and safeguard its interests.
