Advait Group Signs Landmark 1 GWh Cell Supply Agreement with HiTHIUM

This Master Supply Agreement establishes a BloombergNEF Tier 1 partner as Advait strengthens domestic sourcing for utility-scale, commercial and industrial energy storage as for the Advait Gangad manufacturing unit

Ahmedabad, India, September 18, 2026: Advait Battery Ecosystem Private Limited (“Advait Group”), a subsidiary company of BSE and NSE-listed parent company, Advait Energy Transitions Limited, announced that it has entered into a Master Supply Agreement (MSA) with HiTHIUM, a BloombergNEF Tier 1 global energy storage manufacturer, for the supply of lithium iron phosphate (LFP) prismatic battery cells.

The agreement anchors cell supply for Advait’s upcoming 2.5 GWh annual capacity cell-to-container Battery Energy Storage System (BESS) assembly facility and is structured to support cell offtake of up to 1 GWh over the next year, establishing a dependable, high-volume supply chain as Advait scales domestic BESS assembly for grid-scale and commercial and industrial energy storage applications across India.

Under the agreement, HiTHIUM will supply its 314 Ah LFP prismatic cells to Advait, bringing one of the most widely deployed cell platforms in global energy storage into Advait’s domestic manufacturing ecosystem as the company builds capabilities spanning module and pack assembly, container integration and system commissioning.

Commenting on the agreement, **Bhushan Shahane, Chief Operating Officer, Advait Battery Ecosystem Private Limited**, said:

“This partnership with Hithium reflects our belief in partnering with the best: the best cell technology, the best quality and the best service available in the market today. As we scale our 2.5 GWh BESS assembly capacity, a dependable, world-class cell supply chain is central to our ability to deliver cost-optimised, high-performance energy storage solutions to customers across India.”

Hithium is recognised as a BloombergNEF Tier 1 global energy storage manufacturer and is among the leading energy storage battery cell manufacturers globally. The company supplies battery cells and energy storage systems for utility-scale, commercial and industrial, and residential applications across international markets.

The agreement establishes Hithium as a key cell supply partner for Advait as the company builds its domestic BESS manufacturing capacity. The cell supply arrangement is expected to provide Advait with access to high-volume LFP cells as its facility progresses towards commercial production.

“We partnered with Hithium because they represent the gold standard in cell manufacturing: proven quality, consistent performance and a track record with some of the world’s most demanding energy storage developers. Bringing that standard into our supply chain lets us offer the Indian market a cost-optimised solution without compromising on quality, performance or service,” Mr. Shahane added.

Strengthening India’s Domestic Energy Storage Manufacturing Base

Advait’s 2.5 GWh BESS cell-to-container assembly line, currently under development, is central to the company’s strategy of building an integrated, India-based battery energy storage manufacturing ecosystem. The planned capabilities span cell sourcing, module and pack assembly, container integration and system commissioning, providing an integrated manufacturing framework for BESS applications.

The Hithium agreement provides a cell supply framework as Advait prepares to scale production at the facility. With an offtake structure of up to 1 GWh over the next year, the agreement aligns cell sourcing with the planned ramp-up of Advait’s domestic assembly capabilities.

Advait’s collaboration with Hithium also builds on the company’s broader strategy of developing an integrated BESS supply chain through specialised technology partnerships. Advait Battery Ecosystem has already entered into a strategic collaboration with Adaptive Engineering for engineering design, Energy Management System (EMS) architecture, PLC/SCADA and system integration capabilities. With Hithium now strengthening the critical cell supply side, Advait is advancing this partnership-led ecosystem to the next level, bringing together cell sourcing, EMS and engineering expertise, module and pack assembly, container integration and system commissioning under its growing domestic BESS manufacturing platform.

The facility, in Gangad, Gujarat, is scheduled to begin commercial production soon. It is being developed to serve utility-scale, commercial and industrial, and renewable integration applications as Advait expands from project-level BESS deployment towards volume manufacturing.

Advait Energy Transitions Limited, the group’s listed parent company, is a Gujarat-based new & renewable energy & power company with an active portfolio spanning battery energy storage manufacturing, green hydrogen project development, electrolyser manufacturing, fuel cell

manufacturing and clean energy EPC. The Hithium agreement supports the group's broader expansion across energy transition technologies and infrastructure.
