**UPON hearing the counsel the Court made the following
O R D E R**

1. All the special leave petitions have been presented before this Court more than a year after expiry of the prescribed period of limitation.
2. Cause shown for condonation of delay is not only insufficient, the petitioner has attempted to hoodwink the Court by taking shelter of falsehood.
3. The applications seeking condonation of delay in presentation of the special leave petitions stand rejected.
4. Consequently, the special leave petitions are dismissed as time-barred with cost of Rs.25,000/- [Rupees twenty-five thousand] only in each such petition.
5. Let the costs be deposited with the Secretary General of this Court within two months from date. Once deposited, the Secretary General shall identify four organizations across the country which are running homes for intellectually disabled children (children with special needs). Once identified, the amount on account of costs, as imposed, shall be divided in equal shares and paid to them.
6. Pending interlocutory application(s), if any, shall stand disposed of.
