Pursuant to the provisions of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with Sub-Para 8 of Para B of the SEBI Master Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024, and the Industry Standards on Regulation 30 of the SEBI Listing Regulations, we would like to inform you that OAL has received a Show Cause-cum-Demand Notice bearing No. Vad-1/Prev/SCN/51/Oriental/2026-27/Gr.E dated August 25, 2026, from the Office of the Principal Commissioner, Central GST and Central Excise, Vadodara-I, which was received by the Company via email on 26th August, 2026 at 18:19 hours.

The said Show Cause-cum-Demand Notice is received under Section 74 of the Central Goods and Services Tax Act, 2017, seeking details and clarifications in relation to transactions undertaken with a vendor during the period from 1st April, 2020 to 31st March, 2025, along with relevant supporting documents and records.

We will be filing appropriate response to the said Show Cause Notice within the prescribed timelines.

Brief summary of the material contents of the communication received, including reasons for receipt of the communication	The said Notice is received under Section 74 of the Central Goods and Services Tax Act, 2017, proposing recovery of IGST ITC (Input tax credit) of ₹95,68,533/- along with applicable interest and penalty under Section 74(1) of the CGST Act, 2017. The Notice also proposes penalty under Section 122(i) in respect of ITC of ₹15,962/- allegedly passed on to a non-existent supplier. The Notice further requires the Company to show cause as to why proceedings under the applicable provisions of the GST law should not be initiated.
6.	Period for which communication would be applicable, if stated	This Show cause notice covered period of 5 financial years i.e. from 1 st April 2020 to 31 st March 2025
7.	Expected financial implications on the listed company, if any	At this stage, the communication is only a Show Cause Notice (SCN) and no financial liability has been crystallized. The Company is evaluating the transactions and will submit its response before the GST Authority. Accordingly, no immediate material financial impact is ascertainable, and any potential

Details of any aberrations/non-compliances identified by the authority in the communication	The Show Cause Notice states that, based on the Department's investigation, a vendor of the Company whose GST registration was suspended, has been viewed by the Department as a non-existent supplier. Accordingly, the Authority has raised certain observations regarding the transactions undertaken by Oriental Aromatics Limited with the vendor. The Notice, inter alia, raises concerns regarding the transactions with the said vendor, the eligibility of Input Tax Credit (ITC) availed in respect thereof, and the adequacy of supporting records and documentary evidence relating to such transactions.
