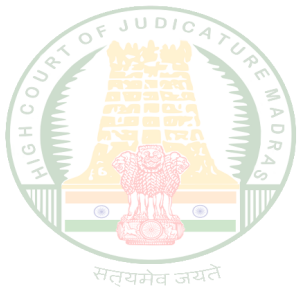

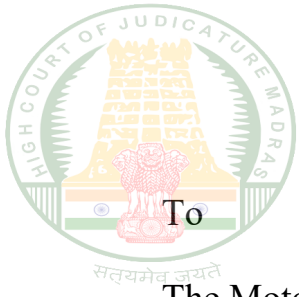
This petition has been filed to condone the delay of 14 days in filing the above Appeal in C.M.A.SR.No.138578 of 2024.

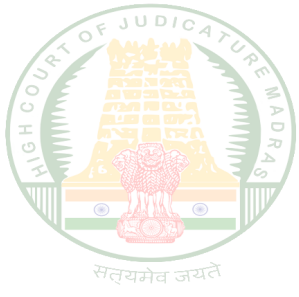

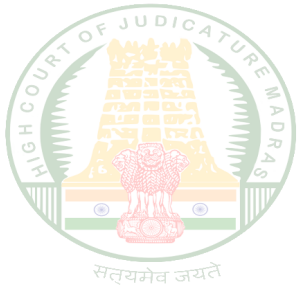
