UPON hearing the counsel the Court made the following
O R D E R

1. Heard Mr. Debal Banerji, learned senior counsel appearing for the petitioner.
2. Delay condoned.
2. The grievance of the learned senior counsel for the petitioner is that an Order XXXIX Rule 4 Code of Civil Procedure, 1908 application filed as early as on 10th October, 2024 has not yet been adjudicated. Learned senior counsel submits that IA No.43053 of 2024 which is the Order XXXIX Rule 4 CPC application ought to be heard either prior to Contempt Application being IA No.44165 of 2024 or that it should heard simultaneously on the same day.
3. We find merit in this prayer. We are told that the applications, including the application under Order XXXIX Rule 4 CPC are listed before a learned single Judge of the Delhi High Court tomorrow i.e. 21st August, 2026, we have no doubt that if the same prayer is made before the learned Judge, the learned Judge will hear the Order XXXIX Rule 4 CPC application along with the Contempt Application and pass suitable orders.
4. With this liberty, the Special Leave Petition is disposed of.
5. Pending application shall also stand disposed of.
