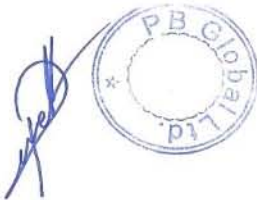

1. We have reviewed the accompanying Statement of unaudited financial results of **PB GLOBAL LIMITED** (hereinafter referred to as the Company') and its share of the net profit after tax and total comprehensive income for the quarter ended 30th June, 2026 (the 'Statement'), being submitted by the company pursuant to the requirements of Regulation 33 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the 'Listing Regulations').
