IA(IBC)/311/KOB/2026 in CP(IBC)/04/KOB/2024

This application has been filed with the following reliefs: -

- i. Declare that the claim application, Annexure A-5, submitted by the Applicant before the Interim Resolution Professional, having been duly received and verified during the Corporate Interim Resolution Process, shall be deemed to have been submitted to the Liquidator under Sec 38 of IBC, in terms of Regulation No 12 (2) (c) of IBBI (Liquidation Process) Regulations 2016, in exercise of the powers conferred on this Hon'ble NCLT, under Section 60(5)(c) of the Insolvency and Bankruptcy Code, 2016 read with Rule 11 of the NCLT Rules, 2016;*
- ii. Direct the Liquidator, 3rd respondent, to accept the Annexure A-5 application filed before the Interim Resolution Professional as a claim submitted by the Applicant before the liquidator under Section 38 of the IBC, as envisaged in clause No 12(2)(c) in the IBBI (LP) Regulations, 2016, and to verify the same as provided under Section 39 of the IBC read with clauses 19 (4) and 30 of the IBBI (LP) Regulations, 2016 and to pass appropriate orders under Section 40 of the IBC, and thereafter to communicate the decision regarding admission or rejection of the claim to the Applicant / workmen within a specified time as the Honorable Tribunal may deem fit and proper;*
- iii. Direct the Liquidator not to distribute the sales proceeds pending adjudication of the applicant's claim, Annexure A-5, and*
- iv. Grant such other reliefs as this Hon'ble Tribunal may deem fit and proper, in the facts and circumstances of the case.*

Ld. Counsel, Mr. Hazan K A appears physically for the applicant sought an adjournment. At his request, case is adjourned to **22.07.2026**.
