UPON hearing the counsel the Court made the following
O R D E R

1. Petitioner challenges the judgment dated 13.02.2024 in Civil Revision No.796/2023 titled "*Olpherts Private Ltd. vs. Sarla Devi Mahila Mandal and Ors.*" passed by the High Court of Madhya Pradesh at Jabalpur.
2. We have heard learned counsel for the parties.
3. It is not in dispute that the suit premises already stand handed over by the respondents to the petitioner. In this view of the matter, we are of the considered view that continuance of the suit, more so, in view of the stand taken by the respondents herein before the High Court in their own appeal being Writ Appeal No.3105 of 2024, would be nothing but an abuse process of law. As such, the Civil Suit No.218/2021 titled as "*Sarla Devi Mahila Mandal & 1 Anr. vs. Olphert Private Limited & Anr.*" pending in the Court of Third Civil Judge, Junior Division, Katni, Madhya Pradesh is dismissed.
4. Accordingly, the present Special Leave Petition is disposed of in the aforesaid terms.
5. Copy of the order shall be placed on the file of the civil suit.
6. Pending application(s), if any, shall stand disposed of.
