The applications for intervention are allowed.

Applications for directions have been filed by persons claiming to be employees of the Sahara Group of entities, seeking verification, computation and release of their outstanding salary dues along with consequential benefits.

Heard the learned Amicus Curiae as well as the learned Senior counsel and the learned counsel appearing for the

parties.

It is submitted that it would be impossible for the learned Amicus Curiae to undertake the exercise of verifying and computing the aforesaid claims of the applicants due to the voluminous nature of the records involved, and that a Committee may be appointed to conduct the said exercise.

In such view of the matter, we deem it appropriate to constitute a Committee to undertake the exercise of verification and computation of the claims of the aforesaid applicants. Accordingly, it is directed as follows:

1. The Committee shall be chaired by Hon'ble Mr Justice Rajiv Sahai Endlaw, retired Judge of the High Court. The Chairperson shall be entitled to an honorarium of ₹5,00,000/- (Rupees Five Lakhs only) per month.

2. The Chairperson shall be at liberty to seek the assistance of such persons as he may deem necessary for the effective discharge of the Committee's functions. Such assistance may include officers from the District Judiciary, Chartered Accountants, or any other person possessing the requisite expertise. Every person so engaged by the Chairperson shall be entitled to an honorarium of ₹2,50,000/- (Rupees Two Lakhs Fifty Thousand only) per month.

3. The Committee shall be at liberty to engage any

additional personnel or support staff as may be necessary for the expeditious completion of the exercise.

4. In addition to the remuneration expenses of the members of the Committee, an amount of Rs. 25,00,000/- (Rupees Twenty-Five Lakhs only) shall be made available towards all incidental and administrative expenses connected with the functioning of the Committee.

5. The learned Chairperson of the Committee shall coordinate with the learned Amicus Curiae to facilitate the release of funds from the 'SEBI-Sahara Refund Account' held by the SEBI, towards the remuneration and administrative expenses of the Committee.

6. The Committee shall be at liberty to devise and adopt its own procedure for conducting the exercise of verification and quantification of claims, in accordance with law.

7. We make it clear that the Committee shall only consider the claims of those persons whose applications have been taken on record vide this order. The Registry is directed to furnish to the Chairperson a copy of the list filed by the learned Amicus Curiae containing the particulars of all such applications.

8. The Sahara Group and all concerned stakeholders shall extend their full support and cooperation to the Committee and shall furnish all records, documents, accounts and such other material as may be required by the Committee

for verification and quantification of the claims.

9. The Committee shall complete the exercise of verification of the claims and quantification of the amounts payable, within a period of three months from the date of commencement of its functioning and shall submit its report to this Court. Upon receipt of the aforesaid report, appropriate orders regarding the release of the amounts shall be passed by this Court.
