1. Mr. A. Pareek, CS, appearing on behalf of the Petitioners.
2. Mr. B. Debnath, CS, appearing on behalf of Respondent Nos. 2, 3 & 7.
3. Mr. L. Bagaria, CA R-8 is present in person.
4. None appears for the other Respondents Nos. 1, 4, 5, 6, 9 & 10.
5. Learned Counsel for Respondent Nos. 2, 3 & 7 submitted that Respondent No. 6 is a company and the said company has been struck off by the ROC, NER.
6. Learned Counsel for Respondent Nos. 2, 3 & 7 further submitted that he is pressing **IA(Comp. Act.)/12/GB/2023** and does not want to file any reply against the main CP.
7. Respondent No. 8 seeks time for filing reply. Reply be filed within 7 days under copy to the opposite parties.
8. None appears for Respondent Nos. 1, 4, 5, 6, 9 & 10.
9. Publication against these Respondents has already been effected.
10. Since none is appearing on behalf of Respondent Nos. 1, 4, 5, 9 & 10. Therefore, they are hereby set *ex-parte*.

11. Learned CS Mr. A. Pareek for the Applicant submitted that interim relief may be granted against the Respondents, which was strongly opposed by the learned CS for Respondent Nos. 2, 3 & 7.
12. It was brought to the notice that the prayer for interim relief had been made in the year 2023 in the main CP.
13. As submitted by Respondent Nos. 2, 3 & 7, there has been no change in the shareholding or fixed assets after filing of the main CP.
14. Therefore, the request of the learned CS for the Applicant, Mr. A. Pareek, for interim prayer is hereby not considerable.
