Suneela Rani, Mr. Kambam Prasad Reddy and Trident Chemphar Limited, are members of the promoter and promoter group of the Company (collectively referred to as "<b>Petitioners</b>").</p> <p>The Petitioners had filed a settlement application with SEBI under the Settlement Regulations in relation alleged violation of Regulations 3 and 4 read with Regulation 12 (2) of the Securities and Exchange Board of India (Prohibition of Insider Trading) Regulations, 1992. On May 6, 2020, SEBI passed a settlement order ("<b>Settlement Order</b>").</p> <p>Subsequently, on October 23, 2020, SEBI issued an email to the Petitioners, directing the Petitioners to deposit profits (i.e. Rs. 6.53 crores) made in the trading in the shares of the Company along with interest @ 12% per annum from the date of the violation till the date of filing of revised settlement terms, into the Investor Protection and Education Fund, within 15 calendar days ("<b>Impugned Communication</b>").</p> <p>The Petitioners filed a writ petition before the Hon'ble High Court of Telangana, Hyderabad, to set aside the Impugned Communication ("<b>Writ Petition</b>"). The Hon'ble High Court of Telangana, Hyderabad, by its order dated May 6, 2026, has dismissed the Writ Petition ("<b>Order</b>").</p> <p>The Petitioners, in consultation with their respective legal advisors, shall decide on the future course of action in this regard.</p>
