Dear Sir/Ma'am,

Pursuant to Regulation 30 of Listing Regulations read with the SEBI Master Circular no. HO/49/14/14(7)2025-CFD-POD2/I/3762/2026 dated January 30, 2026, we would like to inform that there is a dispute between one Mr. Balaji Shivdas Pawar, Partner of Minakshi Agro Industries LLP ("MAILLP"), a subsidiary of the Company. Mr. Balaji Pawar has filed a Statement of Claim dated June 6, 2026 before the Sole Arbitrator Smt. Sadhana Jadhav, former Judge of Hon'ble Bombay High Court, claiming an amount of Rs.25,53,62,813/- (Rupees twenty five crores fifty three lakh sixty two thousand eight hundred and thirteen only) together with interest at the rate of 18% per annum from the date of filing the Statement of Claim till realisation. The said Mr. Balaji Pawar has also made the Company a Respondent in the arbitration.

The Statement of Claim was received by the Company on June 6, 2026 at 3:06 pm.
