UPON hearing the counsel the Court made the following
O R D E R

1. It is fairly conceded by Mr. P.S. Patwalia, learned senior counsel for the petitioners that the order dated 08.09.2026 regarding deposit of Rs.5 crores with the Registry of this Court has not been complied with. He submits that instead of pressing IA No.277117/2026, which seeks modification/clarification of the said order, the petitioners beseech this Court to grant two weeks' time to deposit not less than Rs.2 crores, with the Registry of this Court, along with a proposal to discharge the entire loan liability.
2. Although the past conduct of the petitioners does not inspire confidence, upon taking a lenient view and to ensure compliance of the above statement, as a last opportunity, two weeks' time is granted to the petitioners to honour the above statement.
3. Post the matter on 05.10.2026.
4. The exemption granted to the petitioners from surrendering shall continue to operate till 05.10.2026.

5. The petitioners shall, however, deposit their Passports with the Registry of this Court within two days from today.
