Heard Shri Puneet Kumar Saxena appearing for the Respondent No.1 as well as Ms. Palak Kalra appearing for Respondent Nos. 2 and 3, who prays for and are granted two weeks' time to file reply with an advance copy to learned counsel for the Appellant, who in turn if so wish may file the rejoinder within one week thereafter.

2. Respondent No.4 has still not served and the notice for Respondent No.4 has returned back with endorsement 'addressee has left'. In this regard, we further direct the Appellant to take steps along with requisites to serve Respondent No.4 – Arvind Mittal on his correct address. Steps in this regard be taken within three working days from today.

In view of the explanation given in the application for condonation of delay, the explanation given therein appears to be genuine and the application is thus allowed and delay of two days in filing the appeal is hereby condoned.
