O R D E R

1. Leave granted.
2. This civil appeal is filed against the Judgment and order dated 13.04.2026 passed by the High Court of Gujarat at Ahmedabad in R/Special Civil Application No. 5201 of 2026, directing the appellant herein to deposit entirety of the decretal amount of Rs.22,72,236/- as a precondition for condoning the delay to set aside the ex-parte decree.
3. Having heard Mr. Ashutosh Ghade, learned counsel appearing for the appellants and Mr. Siddarth Dave, learned counsel appearing for the respondents, and considering the matter in detail, we are of the opinion that interest of justice would be subserved if the appellants are directed to deposit an amount of Rs. 15,00,000/- (Rupees Fifteen Lakhs) instead of Rs.22,72,236/-.
4. In view of above, the order passed by the High Court is modified to the extent that the appellants shall deposit Rs. 15,00,000/- (Rupees Fifteen Lakhs)

within a period of two weeks from today.

5. With these directions, the civil appeal stands disposed of.

6. Pending interlocutory application(s), if any, is/are disposed of.
