Pursuant to Regulation 30 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that the Company has today, viz. September 15, 2026, at 12.00 noon received an order from the Commissioner of Prohibition and Excise, Telangana, Hyderabad, **granting Licence for manufacture of Malt Spirits for Potable Purposes at the Company's facility situated at Rangapur Village, Pebbair Mandal, Wanaparthy District, Telangana.**

The Licence has been granted to permit the Company to manufacture **Malt Spirits of a quantity of ~4.4 million BL per annum**, subject to certain terms and conditions prescribed thereunder and under the provisions of the applicable Telangana Excise laws/Rules.
