Pursuant to the provisions of Section 140(2) of the Companies Act, 2013, read with the applicable rules made thereunder and other applicable regulatory requirements, I hereby **tender my resignation** from the office of Statutory Auditor of the Company **with effect from 25-6-2026**.

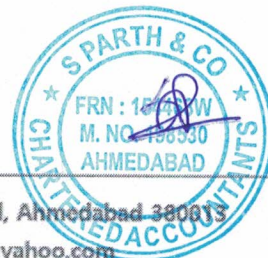
The decision to resign has been taken after careful consideration of the following circumstances:

**1. Non-availability of information and audit records**

Despite repeated requests and follow-ups, the Company has not provided certain books of account, supporting documents, records, explanations and other information considered necessary for the purpose of conducting the statutory audit in accordance with the requirements of the Companies Act, 2013 and the Standards on Auditing issued by the Institute of Chartered Accountants of India. The continued non-availability of such information has materially restricted the performance of audit procedures and my ability to obtain sufficient and appropriate audit evidence.

**2. Outstanding professional fees**

Professional fees remain outstanding and unpaid as on the date of this letter. Despite repeated reminders and follow-ups, the said dues have not been cleared within a reasonable period.



In view of the above circumstances, I am of the considered opinion that continuation of the audit engagement is not feasible and may adversely affect my ability to discharge professional and statutory responsibilities in accordance with applicable legal and professional requirements.

Accordingly, I hereby resign from the office of Statutory Auditor of the Company with effect from **25-6-2026**.

I request the Board of Directors to take note of my resignation and undertake the necessary statutory and regulatory compliances, including intimations and disclosures as required under the Companies Act, 2013, the rules made thereunder and the applicable provisions of the **Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015**.
