O R D E R

SLP(C) No. 24552/2025

Respondent no.1(Caveator) has already filed counter affidavit.

Opportunity of respondent no.2 to file counter affidavit has already been declined vide Registrar Court's order dated 13.04.2026.

Registry to process the matter for listing before the Hon'ble Court as per rules.

SLP(C) No. 24888-24889/2025

Service was complete on respondent no.1 on 16.03.2026 but none has entered appearance.

Counter affidavit filed by respondent no.1 in SLP(C) No.24552/2025 has been adopted by respondent no.2(Caveator) in the instant matter as per Registrar Court's order dated 13.04.2026.
