GBL Chemical Limited ("**GBL Chemical**"), we would like to inform you that the Hon'ble National Company Law Appellate Tribunal, Principal Bench, New Delhi *vide* its order dated June 30, 2026, has dismissed the appeal filed by Profin Private Limited seeking initiation of corporate insolvency resolution process against the Company under the Insolvency and Bankruptcy Code, 2016 ("**NCLAT Order**").
