1. The Settlement Format dated 16.06.2026, forwarded by the District Legal Services Authority, Hisar, is placed on record.

Learned counsel appearing for the respondent-Insurance Company submits that she also has instructions that the parties have settled their dispute and as per the settlement terms, the respondent-Insurance Company has to pay a lump sum amount of Rs.13,50,000/- (Rupees Thirteen Lakhs and Fifty Thousand Only) to the petitioner-claimant within thirty days from the date of the passing of the award.
