O R D E R

1. This Miscellaneous Application is filed by the petitioner/appellant seeking modification/recall of the Order dated 7-8-2026 of dismissal of the Special Leave Petition and also to place on record the settlement arrived at between the petitioner/appellant (accused) and Respondent No. 2 (complainant), in the complaint under Section 138 of the Negotiable Instruments Act.

2. Taking into consideration the averments made in the M.A., the Special Leave Petition is restored to its original number on the file.

3. Leave granted.

4 The learned Counsels appearing for the appellant as well as the respondents submit that the appeal may be disposed of in terms of the Memorandum of Settlement placed on record as Annexure A/1.

5. The Settlement clearly indicates that the appellant - herein, who is the accused, has furnished two demand drafts; demand draft dated 17.08.2026 Numbered 156835 drawn on Cheriya Branch, State Bank of India of Rs.22 Lakhs and demand draft dated 17.08.2026 Numbered 130519 drawn on Cheriya Branch, State Bank of India of Rs. 3 Lakhs.

6. Considering the settlement, the appeal is disposed of, setting aside the conviction and sentence ordered by the Special Magistrate-II Cyberabad at Malkajgiri. The Orders in appeal and revision of the 4th Additional Metropolitan Sessions Judge, Ranga Reddy District and the Telangana High Court are also set aside.

7. The appellant is hence directed to be released forthwith from the prison, if imprisoned, pursuant to the Order of conviction, if not required in any other case.

8. With the aforesaid, the appeal stands disposed of.

9. Pending application(s), if any, shall also stand disposed of.
