The order pertains to the adjudication of stamp duty on the Scheme of Arrangement (Demerger) between Aarti Industries Limited (Demerged Company) and Aarti Pharmalabs Limited (Resulting Company) sanctioned by the Hon'ble National Company Law Tribunal (NCLT), Ahmedabad Bench vide its order dated September 21, 2022.

Details of the violation(s)/contravention(s) committed or alleged to be committed	Alleged short payment/non-payment of stamp duty under the Gujarat Stamp Act, 1958, on the Order of the NCLT, Ahmedabad Bench dated September 21, 2022, approving the Scheme of Arrangement (Demerger) of the Pharma Division of Aarti Industries Limited into Aarti Pharmalabs Limited. However, the Company is in the process of evaluating the order and it believes that it has a strong case on merits and will challenge the order passed by the Stamp Authorities. The Company believes that it has adequate factual and legal grounds to reasonably substantiate its position in this matter and considering the same, the Company will be taking appropriate course of actions for challenging the said order.
