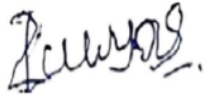

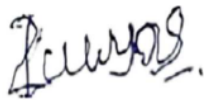

We confirm that there are no disagreements, unresolved matters, or other concerns relating to the accounts, operations, or governance of the company that led to this resignation.

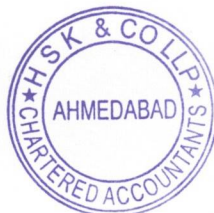
