Subsequently, the Company filed a rectification application before the Jurisdictional Assessing Officer. After considering the submissions made by the Company, the Deputy Commissioner of the Income Tax Department passed a Rectification Order, resulting in a reduction of the tax demand from Rs. 29.03 Crores to Rs. 5.89 Crores.
