d) direct that no order be pronounced in CP/161(CHE)/2022 or any connected proceeding in a manner that would dispose of, render infructuous, prejudice, or effectively pre-determine the issues arising in the present application before the same is decided;

e) direct preservation of the video recording, audio recording, transcript, VC log, cause-list movement record, court-master notes, order-sheet notes and all other available records relating to the proceedings conducted on 08.05.2026 in CP/161(CHE)/2022 and the connected proceedings;

f) direct preservation of the video recording, audio recording, transcript, VC log, cause-list movement record, court-master notes, order-sheet notes and all other available records relating to the mentioning/proceedings, if any, stated to have occurred on or about 04.05.2026 concerning CP/161(CHE)/2022 or the affairs, properties or records of Schempp Ayurvedic Products Private Limited;

g) grant such further or other orders as this Tribunal may deem fit and proper in the facts and circumstances of the case and in the interests of justice.”
