

To Whom It May Concern

This is to certify that **Lokesh Machines Limited (Lokesh Machines)** was removed from the **Specially Designated Nationals and Blocked Persons (SDN) List** maintained by the **United States Department of the Treasury, Office of Foreign Assets Control (OFAC)** on **30 June 2026**. The removal forms part of OFAC's public notice dated **30 June 2026** regarding amendments to the SDN List. It may be noted that the Ministry of External Affairs engaged with the concerned authorities of the Government of the United States – U.S. Treasury and the U.S. Department of State during the course of the review process. Following OFAC's review, **Lokesh Machines Limited** was removed from the SDN List and is no longer designated under **Executive Order 14024**.
3. The company has also received a formal communication from OFAC informing it that its designation has been removed from the SDN List and that the property and interests in property blocked solely as a consequence of that designation are unblocked. **Copy of the OFAC communication to the company is enclosed.**
4. This letter is being issued to confirm the above facts for the information of banks, financial institutions, customers, suppliers, business partners and other interested parties that have business dealings with **Lokesh Machines Limited**.
