O R D E R

- 1. Permission is granted to file Special Leave Petition.**
- 2. Heard Mr. Siddharth Banthia, learned counsel appearing for the petitioner.**

3. Learned counsel draws attention of the Court to the following order passed by this Court on 28th October, 2020:

"We are not inclined to entertain this writ petition filed under Article 32 of the Constitution of India, which is dismissed. However, it shall be open for the petitioner to make a request to the NCLT for early disposal of the application bearing No.CA-1061(PB) of 2019.

Pending application (s), if any, stands disposed of."

4. Learned counsel further draws attention of this Court to the following order of this Court dated 29th August, 2022:

"Permission to file Special Leave Petition is granted.

It cannot be disputed that the proceedings before National Company Law Tribunal (NCLT) for approval of the Resolution Plan are required to be decided and disposed of at the earliest. Considering the fact that earlier the NCLAT as well the High Court have observed and directed to dispose of the proceedings pending before the NCLT at the earliest and despite the same, the same have not been decided and disposed of till date and considering the fact that next date of hearing before the NCLT is 31.8.2022, we refuse to entertain the present Special Leave Petition.

However, we direct the NCLT to finally decide and dispose of the proceedings pending before it at the earliest, but not later than four weeks

from 31.08.2022.

With this, the present Special Leave Petition stands dismissed/disposed of.

Pending application(s) shall stand disposed of."

5. Learned counsel submits that in spite of the orders directing expeditious disposal of the proceedings, the application for approval of the plan has still not been disposed of.

6. We are of the opinion that in spite of the specific orders passed by this Court as early as 2022, the matter before the National Company Law Tribunal has still not been disposed of. Considering that a large number of home buyers are involved, steps need to be taken on a war footing.

7. Considering that there is a new President who has taken over, we are of the opinion that our order should be placed before the new President, Justice retired Shri Anupinder Singh Grewal, former Judge of the High Court of Punjab and Haryana and currently President of the National Company Law Tribunal. Learned President may either take up the matter himself or assign it to a Bench so that the entire pending proceedings are disposed of within a period of six weeks from today.

8. Let a copy of this order be sent to the Registrar, National Company Law Tribunal, New Delhi. The Registrar shall place the order before the Hon'ble President. The Registry of the National Company Law Tribunal shall send a compliance report to this Court within a period of eight weeks from today with regard to the disposal of the proceedings by the Tribunal.
