**ORDER**

**IA/1753/2026:** - This Application has been filed by one of the Operational Creditors, who is a member of the CoC. In this case, the CoC consists of only the Operational Creditors as there are no Financial Creditors. One of the Operational Creditor holding 48.84% voting share has moved the present Application for replacement of the IRP. It is submitted that in the first CoC meeting held on 14.04.2026, CoC has passed the Resolution to replace the IRP and to appoint Mr. Raju Mangilal Marshiya as the new RP of the Corporate Debtor. The Minutes of the said meeting are annexed as Annexure-4, perusal of which shows that CoC with aggregate voting share of 67.28% has approved the said Resolution to appoint the new RP. Accordingly, this IA **stands allowed and disposed of.**



**IA/1763/2026:** - This Application has been filed by the IRP to place on record report for first re-constitution of the CoC and also the list of Creditors. The revised CoC consists of six (6) Operational Creditors in place of earlier five (5) Operational Creditors. The updated/revised list of creditors is also annexed to the Application as Exhibit-B. Accordingly, the Report of Re-constitution of the CoC alongwith the updated/revised list of creditors is taken on record. As there are no further orders to be passed, this IA **stands disposed of.**
