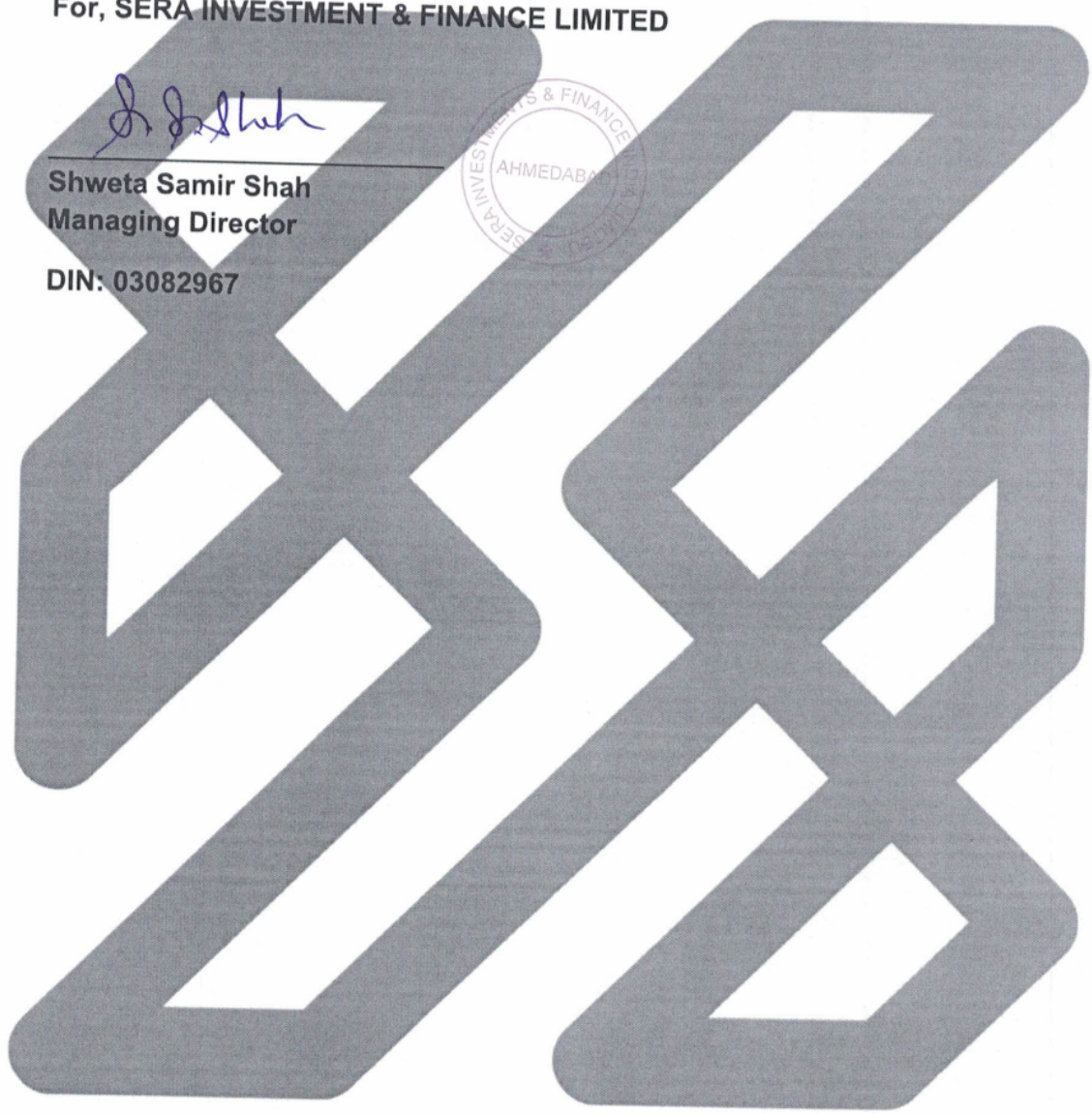

This is in reference to the application submitted by Sera Investments & Finance India Ltd ("Company") for seeking Reclassification of Promoter Shareholders under the provisions of Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

As per Regulation 31A(8)(c) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (SEBI LODR), in case of receipt of request for re-classification by the listed entity from the promoter(s) seeking re-classification, the disclosure is required to be submitted with the Stock Exchanges within 24 hours from the occurrence of the event w.r.t. to submission of the application by the Listed entity for seeking no-objection from recognized Stock Exchanges. The Company submitted the application with stock exchanges on August 27, 2025. It was observed that the aforesaid disclosure was submitted on April 09, 2026, whereas it should have been submitted on or before August 28, 2025.

You are hereby advised to be careful in future, exercise due diligence and initiate corrective steps to avoid recurrence of such lapses so as to ensure due compliance with the applicable provisions of SEBI LODR and related SEBI circulars.
