Post allotment of aforesaid equity shares, the issued and paid-up equity share capital of the Bank stands increased from ₹ 86,21,70,95,230/- comprising of 8,62,17,09,523 equity shares of ₹ 10/- each fully paid-up to ₹ 86,22,19,62,360/- comprising of 8,62,21,96,236 equity shares of ₹ 10/- each fully paid-up.
