UPON hearing the counsel the Court made the following
O R D E R

1. In continuation of our order dated 09.12.2024, we appoint Pricewaterhouse Coopers (PwC) at Chennai as the Forensic Auditor to conduct the forensic audit of the accounts of the auction purchaser – respondent no.3 with respect to the expenditure said to have been incurred on renovation of the hotel after the auction. The Forensic Auditor will also indicate the estimated market value of the hotel on the date of auction.
2. The aforesaid report may be submitted within one month from today. For the time being, the petitioner shall pay the requisite fees to the Forensic Auditor, subject to adjustment of such expenditure at the time of final disposal of the matter.
3. The petitioner shall supply a copy of this Order to Pricewaterhouse Coopers (PwC) at Chennai, forthwith.
4. Post the matters on 10.09.2026.
