Dear Sir/ Ma'am,

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that Silicon Rental Solutions Limited has entered into a Platform Service Agreement with WeWork India Management Limited.

The Company's offering under the arrangement covers IT equipment on rental, IT equipment sales, deployment, maintenance and asset lifecycle management, and e-waste collection and disposal. Under the arrangement, the Company will be listed as a service provider on WeWork India's member platform, through which members may discover and procure the products and services offered by the Company.

The agreement is for an initial term of three years, with a provision for renewal. The services will be contracted and provided by the Company directly to the respective members in its own name. WeWork India's role is limited to that of a platform facilitator, and it will not itself provide the aforesaid services.

The Company will pay WeWork India a referral fee on services converted through the platform, on commercially agreed terms. The arrangement is non-exclusive and does not involve any minimum volume of business, referrals or revenue commitment by WeWork India.
