**Sub: Disclosure of a Judgement dated May 20, 2026 passed by the Hon'ble Supreme Court of India against Talwandi Sabo Power Limited**

We wish to inform you that the Hon'ble Supreme Court of India has passed a judgement against Talwandi Sabo Power Limited ("TSPL") in an appeal filed by Punjab State Power Corporation Limited and anr.

As you are aware, pursuant to the demerger of Merchant Power Undertaking (as defined in the Scheme) from Vedanta Limited to TSPL, the equity shares issued by TSPL are in the process of listing on BSE Limited ("BSE") and National Stock Exchange of India Limited ("NSE"). In view thereof, we request you to make the following disclosure to the Stock Exchanges on behalf of TSPL.

The requisite details of the said order are set out below:

i. Name of the authority	Hon'ble Supreme Court of India
ii. Nature and details of the action(s) taken, initiated or order(s) passed	The Hon'ble Supreme Court of India, vide order dated 20.05.2026 passed in Civil Appeal Nos. 7436 and 7432 of 2025 filed by Punjab State Power Corporation Limited (PSPCL) and Punjab State Load Despatch Centre (PSLDC), has set aside the judgment dated 18.03.2025 passed by the Appellate Tribunal for Electricity (APTEL), restored the order passed by the Punjab State Electricity Regulatory Commission (PSERC), and allowed the appeals preferred by PSPCL. By the said order, the Hon'ble Supreme Court has upheld the alleged penalty on TSPL for misdeclaration of availability for January 2017 in terms of the Grid Code, along with the applicable Late Payment Surcharge.
