## Sub: Resignation as Statutory Auditors of the Company

We refer to our appointment as the Statutory Auditors of M/s. S V Global Mill Limited ('the Company') pursuant to the shareholder's resolution passed on July 12, 2024 to hold office as the Statutory Auditors for a period of 5 (Five) consecutive years i.e. from the conclusion of 17<sup>th</sup> Annual General Meeting of the Company i.e. from the FY 2024-2025 till the FY 2028-2029, pursuant to the Companies Act, 2013 and the applicable provisions of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.

Pursuant to Section 140(2) of the Companies Act, 2013 read with Rule 8 of the Companies (Audit and Auditors) Rules, 2014, we shall file Form ADT-3 with the Registrar of Companies within the prescribed time. It is clarified that our firm neither has any dispute nor any concern regarding suppression of information by the management for the purpose of carrying out the Audit.

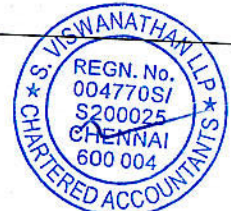
