6. We place on record our appreciation to Mr. Gopal Juneja, representing the Insurance Company, Mr. Rajesh Kumar Gupta, learned counsel for the Insurance Company and Mr. Abhay Choudhary M., learned counsel for the petitioners, for the positive response that they have displayed in bringing the

amicable end to the dispute in this matter.

7. The matter stands disposed of as having been settled.
