2. Learned counsel for the respondents would submit that this petition has rendered infructuous.

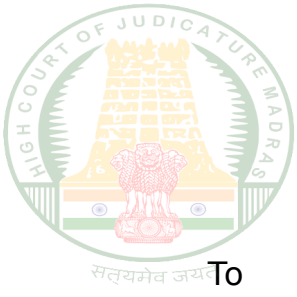
3. In view of the same, the petition stands dismissed. There will be no order as to costs. Consequently, WMP Nos.42528, 42529 of 2025 are closed.
