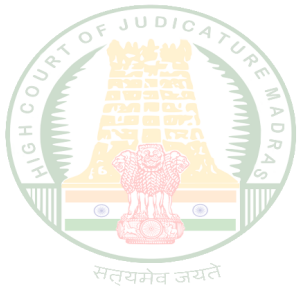

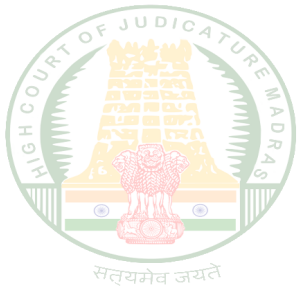

5. With the above direction, this Writ Petition is disposed of.

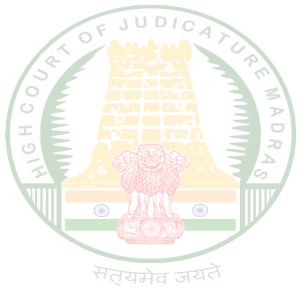

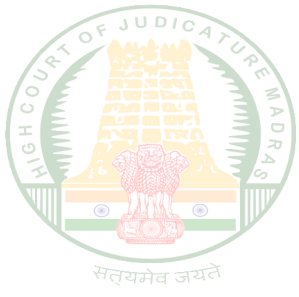
