1. 1. This matter is taken up through Hybrid Mode.
2. Heard Mr. K.C. Sahu, learned counsel appearing for the Petitioner and Mr. S.P. Das, learned Addl. Standing Counsel appearing for the Opp. Parties.
3. The present writ petition has been filed inter alia with the following prayer:-

"It is, therefore, prayed that your Lordships may be graciously be pleased to pass following relief(s):-

(i) The Hon'ble Court be pleased to admit & allow the writ petition.

(ii) (i)The Hon'ble Court be pleased by quashing the impugned order of promotion issued by the Opp. Party no.3 in respect of promotion promotion of Opp. Party No.4 to 8 under Annexure-5, dtd.29.05.2026 with further directing the Opp. Party No.3 to give promotion to the petitioner to the rank of MPHWF, L-I against her UR vacancy on the basis of principle decided vide judgment



dtd.22.01.2026 passed in W.P.(C) No. 7674/2025 & batch if necessary by holding review DPC to that effect by further granting all consequential service benefits in favour of the petitioners within a time bound period for the interest of justice.

(iii) The Hon'ble Court be pleased to pass any other Writ(s), Direction(s), Order(s) as this Hon'ble Court may be deemed fit and proper,

And for this act of kindness, the petitioners shall as in duty bound ever pray.”

4. It is contended that taking into account the judgment passed by this Court on 22.01.2026 in W.P.(C) No. 7674 of 2025 & batch, liberty be given to the Petitioner to move Opp. Party No. 3 for doing the needful as prayed for taking into account the aforesaid judgment.

5. Learned Addl. Standing Counsel has no serious objection to the course of action proposed by the learned counsel for the Petitioner.

6. Having heard learned counsel appearing for the Parties and considering the submission made, this Court while disposing the writ petition, observed that if any such application is moved before Opp. Party No. 3 within a period of two (2) weeks hence, the said Opp. Party shall do well to take a lawful decision on the same within a further period of four (4) weeks from the date of receipt such application.

7. The writ petition accordingly stands disposed of with the aforesaid observation and direction.
