The Board of Directors at its meeting held on 08th May 2026, appointed M/s Rajneesh Sharma & Company, Practicing Company Secretaries (Membership Number FCS: 5549 COP: 24210) as the Scrutinizer for conducting the postal ballot (e-voting process) in a fair and transparent manner.

Members are requested to carefully read the instructions mentioned under the head 'Information and Instructions for e-voting' in this Notice and record their assent (“**FOR**”) or dissent (“**AGAINST**”) on the proposed resolution through the e-voting process not later than 5:00 P.M. (IST) on 15th June 2026, failing which it will be considered that no reply has been received from the Member.

The Company has engaged the services of KFin Technologies Limited (RTA) for facilitating e-voting to enable the Members to cast their votes electronically. In accordance with the MCA Circulars, the Company has made necessary arrangements to enable the Members to register their email address. In terms of the provisions of Section 102 of the Companies Act, 2013 (“the Act”), Secretarial Standard on General Meetings (SS-2) and the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”), the following statements sets out the material facts relating to Item no.1 of this Notice:

1. To approve the re-appointment of Mr. Pritam Singh (DIN: 01168865) as a Non- Executive Independent Director of the Company:

Pursuant to the approval accorded by the members of the Company, Mr. Pritam Singh (DIN: 01168865) is holding the office of Independent Director of the Company and his first term ends on June 17, 2026. The Nomination and Remuneration Committee of the Board of Directors, on the basis of the report of performance evaluation, has recommended the reappointment of Mr. Pritam Singh (DIN: 01168865) as an Independent Director for a second term of 5 (five) consecutive years from June 18, 2026, to June 17, 2031, on the Board of Directors of the Company.

The Board of Directors, based on the performance evaluation and as per the recommendation of the Nomination and Remuneration Committee, considers that, given his professional background and experience and contributions made by him during his tenure, his continuance as an Independent Director would be beneficial to the Company.

In the opinion of the Board of Directors, Mr. Pritam Singh fulfils the conditions for re-appointment as an Independent Director as specified in the Act and the Listing Regulations. Mr. Pritam Singh is independent of the management and possesses appropriate skills, experience, knowledge and capabilities required for the role of Independent Director. Considering the extensive knowledge and experience of Mr. Pritam Singh in the Consultancy services around business analysis, systems architecture, enterprise project, planning and implementation, training and project management, re-appointment of Mr. Pritam Singh as an Independent Director is in the interest of the Company.
