UPON hearing the counsel the Court made the following  
O R D E R

1. In purported compliance with the order dated 10.02.2026, the Gujarat Pollution Control Board has filed an affidavit/compliance-cum-status report. It is claimed that the said Board has prepared a comprehensive and robust action plan for the scientific utilization of funds to the tune of Rs.13.3 crores for the purposes of environmental improvement and restoration. It is further averred that a detailed expenditure report will be submitted to the appropriate forum upon completion of the works and utilization of the funds.
2. While we do not wish to make any adverse observations against the Pollution Control Board for non-disclosure of the plan said to have been prepared for utilization of the funds, nevertheless we deem it appropriate to direct the Member Secretary of the Board to place the same on record along with an affidavit within four weeks. No further opportunity shall be granted.
3. Post the matter on 07.08.2026.
