The notice on behalf of Respondent No. 1, 2 and 3 has been received by Mr. Vikram Kalra, Mr. Aashray Chaudhary, and by Mr. Dhimaan Dutta respectively.

Ld. Counsel for the Respondents prays for and granted two weeks' time to file reply with an advance copy to the Ld. Counsel for the Appellant who in turn if so, wish may file rejoinder within one week thereafter.

Consensus appears to have arrived between Ld. Counsel for the parties that CA (AT) (Ins) No. 884 of 2026 (instant appeal) and CA (AT) (Ins) No. 813 of 2026 (which has been listed as item no. 2 today) and CA (AT) (Ins) No. 1583 of 2024 (which has been listed as item no. 16 today) are to be connected with each other and should be disposed of by passing a common judgment.
