ORDER

1. We have heard Mr. S. Niranjan Reddy, learned senior counsel for the appellant and Mr. Raghvendra Shankar, learned Additional Solicitor General for the respondents and perused the records.
2. In the circumstances of the case and having regard to the findings of fact recorded by the impugned order, we see no ground to entertain the Civil Appeal under Section 62 of the Insolvency and Bankruptcy Code, 2016 (for short, 'the Code').
3. The Civil Appeal is, accordingly, dismissed.
4. After the order is dictated, Mr. S. Niranjan Reddy, learned senior counsel for the appellant submits that the options available to the appellant under Section 12-A of the Code may be kept intact.
5. It is made clear that the order of this Court or for that matter, the order of the Tribunal or the Appellate Authority, is only limited to the extent of admitting an

application filed under Section 7 of the Code and the options under Section 12-A of the Code are left open for the Appellant to pursue.

6. Pending application(s), if any, shall stand disposed of.
