Heard learned senior counsel for the petitioners and learned Additional Solicitor General for the respondent-Union of India.

2. We have been informed that pursuant to the orders passed by the High Court as well as by this Court, the Central Government is considering the proposal with regard to enhancement of age of

superannuation of University Teachers in Punjab University, which has been recommended by the Senate of the Panjab University. It has also been informed that a Committee has been constituted, which would require some further time.

3. Mr. Vikramjit Banerjee, learned Additional Solicitor General appearing for the respondent-Union of India submits that the Court, by way of last indulgence, may adjourn the matters for six weeks to enable the Ministry of Education, Government of India, to finally take a decision on the issue.

4. Having regard to the aforesaid, as jointly prayed for, the matters be listed on 17.11.2026.

5. We make it clear that on the next date of listing, no further adjournment shall be given to the respondent-Union of India.

6. Interim order passed by this Court on 10.10.2022 and extended from time to time, to continue till the next date of listing.
