**1. Observation:** Limited Review Report/ Independent Auditor's Report is not in the format prescribed by SEBI.

**Clarification:** In this regard, we respectfully wish to clarify that the Company had duly submitted the audited standalone financial results along with the **Independent Auditor's Report** issued by the statutory auditors, on May 29, 2025, i.e., in strict adherence to Regulation 33 of the Listing Regulations.

We further wish to submit that the reference to a "Standalone Limited Review Report" appears to be factually incorrect, as the report submitted was, in fact, the Independent Auditor's Report issued pursuant to the statutory audit conducted for the financial year ended March 31, 2025.

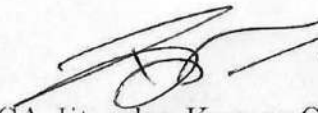
