These appeals under Section 22 of the National Green Tribunal Act, 2019 has been filed by the appellant(s) against impugned judgment dated 24.04.2026 passed by the National Green Tribunal, Principal Bench at New Delhi by which E-auction-cum-E-auction tender notice dated 14.06.2024 issued by District Magistrate, Hamirpur for sand mining leases has been set aside on the grounds that E-tender notice was issued without a valid and final district survey report being in existence.

2. The appellant(s) who had participated in the auction *bona fide* and had deposited the amounts, have

approached this Court.

3. We have heard learned counsel for the parties. We are informed that the amount deposited by the appellant(s) has already been refunded. The grievance of the appellant (s), therefore stands redressed.

4. The appellant(s) are granted the liberty to adopt such measures as are permissible in law for recovery of the interest on the amount deposited by them. We make it clear that we have not expressed any opinion on merits of the case and it is for the appropriate court to consider the claim of the appellant(s) on merits. Accordingly, the Civil Appeals are disposed of.

5. Pending interlocutory application(s), if any, is/are disposed of.

2. Permission is granted.

3. The Special Leave Petition is, accordingly, dismissed as withdrawn.
